This website is partially compliant with the requirements outlined in Appendix A of the UNI CEI EN 301 549 standard, due to the non-conformities listed below. Please note that the company is not subject to the scope of the "Stanca Law" (Italian Law 4/2004), and this statement is made on a voluntary basis. Nevertheless, the Company is committed to making non-accessible content compliant with the applicable regulations.

Non-accessible content

- The page language declared in the code is always English, even when browsing in Italian. This affects screen readers' pronunciation and comprehension of content.
- There is no "skip to content" mechanism when navigating with assistive technologies (Bypass block).
- Page headings do not follow a hierarchical order, and in some cases, the main heading (H1) is missing.
- Several key interactive elements (e.g., back buttons) are not reachable via keyboard navigation.
- Content is only accessible through category-based navigation, without offering alternative methods such as search or an alternate menu.
- Links with generic labels do not clearly convey their purpose, making navigation unclear for users relying on assistive technologies.

- Several interactive or textual elements do not meet the minimum contrast ratio of 4.5:1, and some non-text elements do not meet the minimum 3:1 contrast ratio.
- The focus state of some buttons is not clearly visible, making it difficult for users to navigate via keyboard.
- Carousels do not provide an accessible alternative to swipe, preventing interaction for users relying solely on keyboards or assistive technologies.
- Error messages in form fields are not correctly announced by assistive technologies.
